Guidelines – Please read and initial:

_____ All products brought to the Apple Butter Stirrin’ Festival must be hand-made. Only items listed on this application are permitted to be sold in your booth. **We strongly encourage you to offer apple dishes.**

_____ Food Vendors may wear jeans and t-shirts, provided they are clean and do not have holes. Shirts shall not contain advertising, wording or concert images. Food vendors’ hair should be neat and contained.

_____ Vendors must be set up under a plain white or neutral-colored tent no larger than 12’ x 10 (not provided).

_____ Festival hours are 10am to 6pm on Friday and Saturday and 10am to 5pm on Sunday. Vendors may not vacate the premises nor close their booths before 6pm on Friday and Saturday, or before 5pm on Sunday. This is a matter of courtesy and safety to the public, upon whom you, the vendor, and the Roscoe Village Foundation depend. Those in violation of these rules will not be invited to return the following year.

- ☞ Limited electricity is available for an additional charge. You must state a need for electricity in advance on the contract you will receive if you are approved by the festival committee.
